

Privacy Policy Statement pursuant to and for the purposes of Article 13 EU Regulation 2016/679 – GDPR – Information on the processing of personal data collected from the interested party

This Privacy policy sets out how the SHRINES (raising awareness for the protection of places of worship by promoting interfaith dialogue on the use of advanced technologies) consortium uses and protects any personal information that you provide by registering to the European network for safety and security management in places of worship (hereinafter, 'the Network'). It also explains your rights under the EU Regulation 2016/679 (hereinafter referred to as GDPR).

We reserve the right to modify or simply update this privacy notice, in part or completely, also due to changes in the applicable legislation by updating this page from time to time, you should check page regularly to ensure that you are happy with any changes.

The policy is effective by 1st April 2023.

1. Who We Are

SHRINES is a two-year project co-funded by the European Commission as part of the Internal Security Fund – Police programme. SHRINES aims to enhance the protection of places of worship using novel technological tools and the creation of a European network for safety and security management in places of worship to facilitate the exchange of knowledge, tools, and good practices among different stakeholders involved in managing places of worship.

SHRINES consortium is coordinated by the not-for-profit association SAFE (Security and Freedom for Europe) VAT number 026004600394, with registered office in Via Maggiore 73 48121 – Ravenna, Italy (hereinafter SAFE) who will be responsible for the management and treatment of your personal data (hereinafter, 'data controller').

2. Types of Personal Data We Collect

For the purposes described below, we process the following categories of personal data:

- Contact information: Title, Name, Surname, Role/position in organization, Email address and Phone
- Your organisation information: Name, Country and Address
- User-generated content: Comments or feedback

3. Purposes and Legal Basis for Processing Your Personal Data

We process your personal data for the following purposes:

- a. Communicate and/or send information related to the activities and the outcomes of the project SHRINES;
- b. Communicate and/or send information related to the activities carried out by the Network;
- c. Communicate and/or send information related to the activities of other relevant projects or activities connected to the protection of places of worship;
- d. Publication of anonymous aggregate statistics on the composition of the Network (e.g., geographical coverage);
- e. Publication of organisation names on the website of project SHRINES and related documents (e.g., presentations, factsheets).

For these purposes indicated in the previous paragraph, the legal basis of the processing, certifying its lawfulness, is consent as provided for by art. 6, par. 1, letter a) of the GDPR.

4. Treatment modalities

The data is processed using manual tools, with criteria strictly related to the purposes indicated above and, in any case, in such a way as to guarantee the security, protection and confidentiality of the data, in accordance with the provisions of current legislation. The data may be shared by SAFE with Università Cattolica del Sacro Cuore-Transcrime with registered office in Largo Agostino Gemelli 1, 20123 Milan, Italy (hereinafter UCSC-TC) in order to ensure better coordination of the activities of the project. UCSC-TC undertakes to use the information in full compliance with the purposes and methods described in this Privacy Policy. Specifically, UCSC-TC will act as data processor for the purposes from a) to d) as reported in the article 2 of this Privacy Policy.

Non-personal data about the Name and Country of the organisations can be also share among other members of the SHRINES consortium (hereinafter 'consortium'). The full list of the SHRINES consortium members can be found of the project website.

5. Retention Period for Your Personal Data

The data processed may be retained by the recipients for a period of 10 (ten) years, starting from the date of granting the consent for the related treatment.

6. Your Rights

At any time, you may exercise, pursuant to articles 15 to 21 of EU Regulation no. 2016/679, the following rights with regard to your personal data:

- Right to access: You have the right to request access to your personal data.
- Right to rectification: You have the right to request that we correct any inaccuracies in your personal data.
- Right to erasure: You have the right to request that we delete your personal data.
- Right to restrict processing: You have the right to request that we restrict the processing of your personal data.
- Right to data portability: You have the right to receive a copy of your personal data in a structured, machine-readable format.
- Right to object: You have the right to object to the processing of your personal data.
- Right to withdraw consent: If we are processing your personal data based on your consent, you have the right to withdraw your consent at any time.
